I hereby make application to be considered for full or associate membership in the Rangers, Inc., and if accepted:

4. I agree that if I fail to be selected as a pledge, my application fee (\$30.00) will be refunded to me.
5. I agree that if I am not accepted as a full member after serving as a pledge, no money will be refunded. I also agree to return in good condition all Ranger items in my possession. This includes, but is not limited to, the small Ranger pledge patch, the Ranger friendship pin(s), and the name badge.
